Privacy Policy

We at CBIT Ltd and our affiliated companies worldwide ("CBIT") are committed to respecting your online privacy and recognize your need for appropriate protection and management of any personally identifiable information ("Personal Information") you share with us.

CBIT has established this Online Privacy Policy so that you can understand the care with which we intend to treat your Personal Information.
